#### 1. The Promoter

The promoter is: The Guide Association ("Girlguiding") of 17-19 Buckingham Palace Road, London, SW1W 0PT.

## 2. The competition

- 2.1 The title of the competition is Knorr's Leftover Legends.
- 2.2 To enter, a parent or guardian must take a photograph of their daughter's recipe card and email it to partnerships@girlguiding.org.uk. In the email, they need to include their daughter's name, age and unit. As well as a description of their recipe. One winner from each section will be chosen by Girlguiding and Knorr. Only one entry will be accepted per person.
- 2.3 To enter this competition, the entrant must be a Girlguiding member (an "Entrant").

#### 3. How to enter

- 3.1 The competition will run from 8.00pm on 10<sup>th</sup> July 2024 (the "**Opening Date**") to 00:00am on 2<sup>nd</sup> September 2024 (the "**Closing Date**") inclusive.
- 3.2 All competition entries must be received by Girlguiding by no later than midnight on the Closing Date. All competition entries received after the Closing Date are automatically disqualified.
- 3.3 To enter the competition:
  - For the purpose of this competition, we are defining leftovers as the food remaining after the rest has been used, so this could be half a bag of flour, or half an onion you have left in the fridge from a previous recipe, or a bit of frozen Bolognese from the freezer.
  - Our leftover legends competition is open to Rainbows, Brownies, Guides and Rangers, who can enter as individuals or work together as a unit to create and submit their recipe.
  - To enter, first of all, please let a parent, guardian or leader know you'd like to take part in the competition, and if you're under 14 please either copy them in the email or ask them to submit your entry for you.
  - Remember to stay safe in the kitchen and ask for help with things like chopping and hot
    ovens and dishes.

- To be taken into consideration, all recipes must come with a picture, a list of ingredients used and a step-by-step explanation of how you've made your dish. Please make sure that the photos you submit are only showing the food you've cooked! For GDPR reasons please do not include identifiable imagery such as faces.
- Every dish should contain at least 2 fruits or vegetables.
- Every dish must contain at least 3 items from your fridge or cupboard that have already been opened, even better if they're close to their use by date.
- You can add up to 3 ingredients from your fridge or pantry that haven't been opened yet to your recipe with, make sure to ask your parent or carer for permission before doing so.
- Extra points will be awarded for: how creative the name of your dish is, presentation on photo and amounts of leftovers used.
- You can also get extra points for turning a leftover dish into another dish, for example Bolognese meat turned into cottage pie, using up food that's near its use by date and turning food scraps into ingredients, for example turning potato peels into a crispy topping for your cottage pie.
- You can also get an extra point if your recipe contains a review from a friend or a relative.

Once Entrants have designed their recipe and have prepared the dish, you as their parent, guardian or leader are responsible for submitting it. You need to take a photograph and email it to <u>partnerships@girlguiding.org.uk</u> with the title 'Knorr Recipe competition'. Please include the Entrants' name, age including their unit in the email. Please share all details (provided by the Entrant) about their recipe, including all the things above. Please do not share any images of children under 18.

- (a) Only one entry per Entrant will be accepted.
- (b) You agree to share contact information including the delivery address with the Guide Association Trading Service Limited to receive the prize.

### 3.4 Girlguiding will **not** accept:

- (a) responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.
- 3.5 By submitting a competition entry, you are agreeing to be bound by these terms and conditions.

- 3.8 The winner will be chosen by Girlguiding and Knorr after the competition closes.

### 4. Eligibility

- 4.1 The competition is only open to Girlguiding members in the UK, except:
  - (a) Entrants who are related to (for example, children of) employees of Girlguiding or its subsidiary companies;
  - (b) employees of agents or suppliers of Girlguiding or its subsidiary companies, who are professionally connected with the competition or its administration;
- 4.2 Entrants' parental or guardian consent to enter the competition and claim any prize, is required. Girlguiding may ask the parent/guardian of the Girlguiding winner to provide proof of age/membership.
- 4.3 In entering the competition, you confirm that the Entrant is eligible to do so (in accordance with these terms) and eligible to claim the prize **OR** any prize they may win. Girlguiding may require you to provide proof that the Entrant is re eligible to enter the competition.
- 4.4 Girlguiding will not accept competition entries that are:
  - (a) automatically generated by computer;
  - (b) completed by third parties or in bulk;
  - (c) illegible, have been altered, reconstructed, forged or tampered with; or
  - (d) photocopies and not originals.
- 4.5 Girlguiding reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize competition.
- 4.6 Competition entries cannot be returned.

## 5. The prize

5.1 There are 4 prizes available.

- 5.2 The winning recipes (one from each section) will be turned into recipe cards and posted to the winners, as well as being hosted on the Girlguiding website in a blog.
- 5.3 Prizes are subject to availability. There is no cash alternative for the prize.
- 5.4 The prize is supplied by Guide Association Trading Service Limited ("Trading") of 17-19 Buckingham Palace Road, London, SW1W OPT (the "Supplier"). Girlguiding reserves the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond Girlguiding's control makes it necessary to do so.
- 5.5 The prize is not negotiable or transferable.

#### 6. Winners

- 6.1 The decision is final and no correspondence or discussion will be entered into.
- 6.2 Girlguiding will contact the winner's parent/guardian personally as soon as practicable after the Announcement Date, using the email account provided with the competition entry. Girlguiding will not amend any contact information once the competition entry has been submitted.
- 6.3 Girlguiding must either publish or make available information that indicates that a valid award took place. To comply with this obligation Girlguiding will publicly comment on the winning entries.
- 6.4 If you object to any or all of the Entrant's surname or county being published or made available, please contact Girlguiding. In such circumstances, Girlguiding must still provide the information and winning entry to the Advertising Standards Authority on request.

## 7. Claiming the prize

- 7.1 Please allow 14 days for delivery of the prize.
- 7.2 The prize may not be claimed by a third party on your behalf.
- 7.3 Girlguiding shall make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available, or has not claimed their prize within 7 days of the Announcement Date, Girlguiding reserves the right to offer the prize to the next eligible entrant selected from the correct entries that were received before the Closing Date.
- 7.4 Girlguiding does not accept any responsibility if you are not able to take up the prize.

## 8. Limitation of liability

Insofar as is permitted by law, Girlguiding, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of Girlguiding, its agents or distributors or that of their employees. Your statutory rights are not affected.

### 9. Ownership of competition entries and intellectual property rights

- 9.1 Girlguiding does not claim any rights of ownership in your competition entry.
- 9.2 You agree that Girlguiding may, but is not required to, make your entry/ the Entrant's entry available on its website [www.girlguiding.org.uk] and any other media, whether now known or invented in the future, and in connection with any publicity of the competition. You agree on behalf of the Entrant to grant Girlguiding a non-exclusive, worldwide, irrevocable licence, for the full period of any intellectual property rights in the competition entry and any accompanying materials, to use, display, publish, transmit, copy, edit, alter, store, re-format and sub-licence the competition entry and any accompanying materials for such purposes.

### 10. Data protection and publicity

- 10.1 By submitting a competition entry you are agreeing to receive emails from Girlguiding UK partnership team at <u>partnerships@girlguiding.org.uk</u>.
- 10.2 Girlguiding shall only process your personal information as set out in the Privacy Notice <a href="https://www.girlguiding.org.uk/privacy-notice/">https://www.girlguiding.org.uk/privacy-notice/</a>. See also condition 6.3 and condition 6.4, with regard to the announcement of winners.

#### 11. General

- 11.1 If there is any reason to believe that there has been a breach of these terms and conditions, Girlguiding may, at its sole discretion, reserve the right to exclude you from participating in the competition.
- 11.2 Girlguiding reserves the right to hold void, suspend, cancel or amend the prize or competition where it becomes necessary to do so.
- 11.3 If any term is found to be illegal, invalid or unenforceable it shall be severed and deleted from these terms and conditions, and the remaining terms shall survive and remain in full force and effect.
- 11.4 These terms and conditions shall be governed by English Law, and the parties submit to the non-exclusive jurisdiction of the courts of England and Wales.
